Statement Analysis Overview

What is a statement analysis?

Statement Analysis is a technique used to examine spoken or written statements to uncover hidden meanings, deception, or other important information. The process involves analyzing the words, syntax, and structure of a statement to identify inconsistencies, omissions, and patterns of speech.

By examining the statement closely, an analyst can identify key indicators of deception, such as the use of qualifying language, hesitation, or avoidance.

The following pages show how this technique was used in the Depp vs Heard case.
